5. Fire-fighting measures

Suitable extinguishing media

Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

Extinguishing media which must not be used for safety reasons

Do not use a solid water stream as it may scatter and spread fire.

Special exposure hazards arising from the substance or preparation itself, its combustion products, or released gases

As the product contains combustible organic components, fire will produce dense black smoke containing hazardous products of combustion (see section 10).
